The Warren Bailey Community Service Scholarship - established in 2024 by friends of the Greater Lakes Region Children's Auction to honor the community impact of Warren Bailey and to recognize and promote community service in the youth of the Lakes Region. Warren, who in 1982 was a radio host with WLNH, created a two-day fundraising broadcast from the WLNH van in front of the Laconia YMCA. They raised \$2,100 and collected a number of items to be donated to the "Citizen Santa Fund". Fast forward to 2024, the Children's Auction, along with its hundreds of volunteers annually, has raised over \$9 million on behalf of nonprofits serving children and families in need. **Linda A DeForge Memorial Scholarship –** (1960 – 2024) Born in Laconia NH, Linda was a graduate of Laconia High School and went on to become a CNA/LNA where she touched the lives of the many patients she cared for. Linda was known for her "heart of gold". She took the time to have in-depth conversations with each nursing home resident

she came in contact with. Linda always had a smile and took the time to make everyone feel that they had her undivided attention.



**Anthony & Linda Ferruolo Scholarship -** Established in 2024 by Anthony and Linda Ferruolo. Anthony F. Ferruolo, businessman and community supporter was born and schooled in Rhode Island where he owned and operated a seasonal refreshment franchise in the 1960's. In 1969 he sold the franchise and moved to Jackson, NH to join a group purchasing Whitney's Inn and Black Mt Ski Area. In the late 70's he transitioned into the restaurant industry by becoming a partner in the Red Parka Pub in Glen NH,

and co-founding two B.Mae Denny's Eating & Drinking Establishments in Gilford and Concord NH. Another hospitality transition occurred in 1983 when Anthony partnered to build and then manage B.Mae's Resort Inn & Suites (now Fireside Inn) in Gilford NH. Throughout his business career he devoted time to numerous community organizations: Belknap County Economic Council, The Mt Washington Valley and Lakes Region Chambers of Commerce, Jackson Ski Touring Association, NH Ski Area Operators, New Hampshire Hospitality Association, Gilford Village Knolls Senior Housing, and the Laconia/Gilford Industrial Park. Linda D Ferruolo, M.Ed.C.M.M. was born in Laconia graduating from LHS in 1970. She had various careers during her early life, but with the earning of a Master's degree from PSC (now PSU) she was now on a new path of teaching. Linda also became a Certified Marital Mediator for the state of NH, serving on the Board of Directors for 7 years, the last two as president. She

began teaching volunteer mediators and progressed to teaching for PSC in the Graduate Program. Her final years lead her to teach at Lakes Region Community College, where she was Human Services Program Coordinator for 17 years. Anthony and Linda raised their three children in the Laconia/Gilford area, all three graduated from Gilford High School. Of their four grandchildren, one graduated from GHS, and three from LHS.

**Dr Joseph W & Rita Gage Memorial Scholarship** - Dr. Joseph W. Gage (1927–2005) practiced dentistry for fifty years which does not reveal his myriad achievements and contributions to the Lakes Region Community. In addition to serving his state and country, he was a vanguard in countless professional dental organizations to advance his profession and benefit his patients. He devoted nearly thirty years of wholehearted service to the Laconia School Board and then the Laconia Police Commission. Yet, Dr. Gage is honored and revered, not only for all these accomplishments, but for being the unpretentious, caring person that he was – dedicated to his family, his profession, his patients, his community. Rita Gage (1925 - 2024) was born in Lynn MA. A 1943 graduate from Lynn Classical High School and a 1951 graduate from Boston School of Physiotherapy practiced PT at Boston Psychopathic Hospital. Rita had a love and passion for creative arts, pottery, painting, ballroom dancing and gardening. Throughout their courtship and 53-year marriage, Rita gave Joseph her utmost support to help further his dental career and enable his commitment to service. Her medical education, and experiences as a Physical Therapist, were invaluable assets as they studied together for his dental exams and set up a dental practice to serve the Lakes Region community they both loved. Additional funds were received and the fund was renamed to the Dr Joseph W & Rita Gage Memorial Scholarship upon Rita's passing this past September. Rita was added upon her passing to reflect her many contributions to Dr. Gage's professional and community achievements





**Gilford High School Business Department -** Steve O'Riordan, Business Teacher, for Gilford High School established this fund in 2024. The monies were raised by the GHS Business Dept. students through the Steve O's Subs project, as a way to give back to the community.

**Bryson Peter Haddock Memorial Scholarship** – (1997 - 2024) - Bryson was a life-long, handson learner. Music is what got him to graduation at Laconia High School. Along with the saxophone, Bryson played many other instruments as part of the LHS marching and jazz

bands. He loved singing in the LHS Choir, on swings, back porches, front porches, in his truck, at bonfires and on his motorcycle! Bryson cared deeply about people. His love for meeting new people, like his music, crossed all boundaries. Bryson lived his life as one giant adventure. He never did anything half-way and was always at full throttle. His life was cut far too short by a fatal motorcycle crash.






Robert A. "Bob" Hamel Memorial Scholarship - (1951 - 2023) Bob lived a life dedicated to service and absent of idleness. He was born in Laconia and a



graduate of the LHS Class of '69. He coached his son's sports team, rode his Honda Goldwing with his wife, Kaye, to 45 states and cherished two grandsons. He served in the Air Force and immersed himself in the community where he was born and raised. He could repair anything that needed fixing, drank Moxie and had a secret talent for ice skating. Bob lived in Laconia all his life except for the four years he spent as an Air Force missile systems analyst in Kansas. He coached his son in T-ball, Babe Ruth baseball and youth basketball. He refereed local basketball games and loved to watch the Celtics, Bruins, Patriots and Red Sox with Todd. Bob began more than four decades of community service that made him a pillar in Laconia. He started with the Jaycees. He helped start Laconia's Christmas Village tradition, building temporary houses and an ice rink every December. He would take the ice himself on an ancient, worn-out pair of skates. He served on, and at one point led, the Laconia Parks and Recreation board for 10 years. He worked as a Laconia part-time police officer for a decade. He spearheaded the refurbishment of the Colonial Theatre and the restoration of Laconia High School athletic fields and the Huot Career and Technical Center. He filled a vacancy on the city council in 2005 and was elected for nine two-year terms. He encountered no strangers in Laconia. Bob still found time for the people and activities he loved. Bob and his wife, rode to motorcycle rallies - "Wing

Dings," in honor of their preferred Goldwing - in Tennessee, Wisconsin, Montana, Pennsylvania, New York and elsewhere.

Gary P Hermsdorf Memorial Scholarship - The scholarship was started after Gary's passing in 2024 by a long-time friend. Gary (1944 - 2024) was a graduate of UCONN Pharmacy School and spent his whole life in the pharmacy arena. His passion for pharmacy is the basis for this scholarship. He had a summer cottage in Belmont, NH, and he would have been proud to have been a small part of the scholarship recipients' accomplishments.





James E Lucas Jr Memorial Scholarship - (1965-1994) The US Air flight 1016 which crashed on July 2, 1994 in Charlotte, North Carolina, claimed the lives of 37 people. Among them was James E. Lucas, Jr., a native of Laconia, James was an LHS class of 1983 graduate. At LHS Jim Lucas, admired as a very good student, was also a member of the chess team, and widely known as a quiet, friendly, good-natured young man. Jim enlisted in the U.S. Army after graduation and was a member of the 82nd Airborne. After he completed his tour of duty, he enrolled at the

University of South Carolina to pursue a degree in electrical engineering and had completed his Junior year. Additional funds were received upon the passing of James' mother, Patricia A Millette (1942-2024) this past September.

Bert and Anita Morin Scholarship Fund - Bert (1915-1995) worked in the family business at the Belknap Mills and later was welfare director for 34 years until his retirement in 1989. Anita (1919-2011) worked at Scott & Williams for 37 years until her retirement in 1979. Together they worked for the betterment of their community, church, children and family. Bert coached basketball, baseball, and football for Sacred Heart as a volunteer for 24 years. Anita was the cheerleader, the

sandwich maker and the support system in every aspect. She was always there to help in any way she could. Their work ethics were admirable and their belief in God, kids and education was very important to both of them. The scholarship fund has continued their ideals of giving students a chance to have a decent education and to be the best they can be. Donations were added in 2024 in memory of their daughter, Rachel M Gray. (1941 - 2024) Rachel was known for her keen and curious mind, infectious laughter and lifelong desire to experience and enjoy all that the world had to offer.



John Paradise Memorial Scholarship - (1971-2003) was truly a remarkable young man. He graduated from Gilford Middle High School in 1990 and from the College of Oceanography in San Diego, California. He was a professional diver for a number of oil companies. He graduated

from Plymouth State College in 1997 with a major in business and a minor in economics and worked as a stockbroker in Boston for a year. He was co-founder and co-owner of the Meetinghouse Brewing Co. in Gilmanton. A past member of the Belknap County Sportsman's Association, he loved the outdoors and enjoyed camping, fishing, hunting, and treasured spending time with his wife, Sonsa, at the ocean. He is remembered by family and friends as the most positive and joyful person they knew, who lived life to the fullest, and brought sunshine and laughter wherever he went. He will certainly be missed, but not forgotten by all his family, friends, and colleagues who established this meaningful memorial in his honor. Over the years, many other family members and friends have been commemorated through donations in memory of John,

in particular his grandmother, Marie Louise Paradise (1903-2004) who was described as a cheerful homemaker, a family nurturer. and, his brother-in-law, Fred O. "Bud" Wheeler, Jr. (1952-2014), owner and operator of Wheeler Surveying and Mapping for over 25 years. This year additional funds were received upon the passing of John's


father, Lionel Paradise (1934 - 2024) who owned and operated Paradise Drilling and Blasting for over 30 years in and around the Lakes Region.

Established in 2024 In honor of Steven's 40th birthday, Stevens family elected to pass this opportunity forward. Steve was a natural athlete who enjoyed most sports, but in particular, baseball and football. As a freshman, Steve started on the Jr Varsity team for baseball and football. As a sophomore he played varsity baseball and became the quarterback for Jr Varsity and a safety and backup quarterback for Varsity football. His senior year he was starting quarterback, captain for both baseball and football and was the first at LHS to bat over .500. Steven continued his love of baseball at George Washington and in 2006 graduated with a

psychology degree and is currently a financial advisor. "We wish you much success in your future endeavors and are happy to be part of your journey."

Erin Southworth Memorial Nursing Scholarship - (1974-1978) established in 2024.by her loving parents Deborah Joan Cott Southworth and Michael Thomas Southworth. Erin spent a significant amount of her life in and out of the hospital battling heart disease. Erin was tragically taken much too soon, but her memory and bright spirit live on for a lifetime. Her family is very grateful for the indescribable love, support, and tremendous care that she received from the nursing staff while in their extensive care. The Protecting Americans from Tax Hikes (PATH) Act of 2015 (among other things) made the Qualified Charitable Distribution (QCD) provision permanent. The Pension Protection Act of 2006 introduced the QCD provision for Traditional and Roth IRA owners (or beneficiaries after the death of the owner) who are age 70½ or older to make charitable contributions of up to \$100,000 per year directly from their IRAs to an eligible organization without incurring any adverse federal income tax consequences. The distribution counts for the purpose of the Required Minimum Distribution (RMD) from IRAs, but is not included in calculating the individual taxpayer's limitation on charitable deductions in the year the donation was made.

Q. What are the key benefits of an IRA Charitable Distribution to a charity?

A. The IRA QCD provision can help to bolster your legacy while reducing your taxable estate. While you would not receive a charitable deduction for a transfer from your IRA to a charity, the amount of your transfer would not be included in your gross income, nor would it be subject to income tax. You would have the added satisfaction of knowing that your charity could receive the full amount, with no tax cost to you or to the charity.
